We at the **Hemlock Lake Union Agricultural Society**, would like to extend an invitation to you, to become one of the many vendors that participate in our annual **“Little World’s Fair”**. Located in Hemlock, New York, (approx. 30 miles south of Rochester N.Y. on Rt. 15A) our Fair has now become a tool that can increase your exposure to many hundreds of potential customers. **“The Little Worlds Fair” (The Largest Fair in Livingston County)** is growing in size every year, and we look forward with your help to continue with this trend. It’s our goal to make our Fair **the best little Agricultural Fair in New York State**.

For our Vendors, our Commercial Building and Grange Hall has 24 wall and 8 center aisle spaces available for rent. Out side on the Fair grounds we have over 1,000 front ft. for commercial exhibitors spaces to show and sell their wares. These spaces are rented at a minimum front footage of 15ft. Footage can be added to both the front and depth as needed and as the location will permit. Location preference will be given to prior participants, if not a prior, first come first serve will apply. For layout, location and pricing please review the enclosed documentation. Security is on location 24hrs/day for the duration of the Fair.

Our five (5) day Fair this year will be **Tuesday July 15 through Saturday July 19, 2008**. The weekly entertainment consists of Demolition Derbies, Truck, Tractor and Horse pulls all at the main Grandstand. Daily musical entertainment will be featured in our Festival Building. A Commercial Display Vendor Contract, Concession/Vendor Rules & Regulations and Fair Maps are enclosed for your use. All documents must be

completely filled out to **include all pertinent data**, and any other information you may have that will provide us with the ability to give you the service and space required for your stay at the “**Little World’s Fair**”.

In an effort to increase our vendor visibility and in cooperation with the Genesee Valley Penny Saver, Vendors for a minimal charge can be included in an exclusive Advertising Supplement that is in the area Penny Saver one week prior to our Fair.
